



Employment & Wage Verification Frequently Asked Questions

When would someone need to use employment verification services?

- When applying for a personal loan or a mortgage, renting an apartment or buying a vehicle, an individual may be asked to provide proof of employment and income. Yellow has partnered with Thomas & Company, a national employment and wage verification firm to provide this service.

Please note all entities under the Yellow brand will utilize the YRC code (YRC382).

How does an organization request verification?

- The requester should be directed to www.thomas-and-company.com and have them select the GREEN BUTTON 'Request Employment and Wage Verification' on the home page.
- The organization will need the company code **YRC382** and social security number of employee they are requesting information on.
- For assistance, the requester can email Thomas and Company's Verifications Department at Verifications@thomas-and-company.com or dial (615) 620-0569.

What information does Thomas and Company provide?

- For **Employment Verification only**, the requester will be provided with the following information: first day of work, last day of work (if applicable), position type (full or part-time), and job position.
- For **Employment and Wage Verification**, the requester will be provided with the following information: name, hire date, termination date (if applicable), position type (full or part-time), job position, rate of pay, and year-to-date wage details.
- If wage information is being requested, the employee needs a signed release giving the requester permission to request the verification. Information will not be released without a signed release form

How quickly will Thomas and Company respond to the verification request?

- Thomas and Company responds within 1 to 2 business days using the requester's preferred method, fax or email. For an urgent request, the requester can email the Verifications Department at Verifications@thomas-and-company.com or by dialing (615) 620-0569.

Is there a charge for this service?

- The requesting organization is charged a nominal fee for this service. If the requesting party is unable to use the web portal, they can call the Verifications Department at (615) 620-0569 to request and make alternate payment arrangements.

Is there a different process for government agency requests?

- Government agency requests for employment and/or wage information can be emailed, faxed or mailed to Thomas and Company's Verifications Department. See contact information below.
- Thomas and Company will complete the request and return the information directly to the requester.
